## Youth Discount Program

### 10% OFF LIVESTOCK

### SUPPLIES

The 10% discount given on livestock supplies will be allowed year round from the **regular** retail price. This discount is open to all 4-H/FFA members. A chargeable account is not required for this discount. The discount will be given from the regular retail price, no other discounts or promotions apply.

#### Discount applies to:

- All bagged feed products  
\*excludes bulk feed products
- Feeding equipment
- Grooming equipment
- Show Supplies
- Animal health products
- Minerals and salt

### APPAREL

The clothing discount can be applied on all clothing and footwear, worn during the process of showing your animals. The discount will be given from the regular retail price, no other discounts or promotions apply.

# Youth Market Charge Account

## Program

- The Co-op will allow qualifying students to open an interest free charge account to assist them in raising their market animal.
- Each student is allowed one account for the designated market animal of choice (steer, pig, or lamb).
- **A parent/guardian guarantor will be required on all charge accounts.**
- Approved charge accounts receive interest free financing on qualifying feed and show products.

#### Credit limits are as follows:

- |         |            |
|---------|------------|
| • Steer | \$1,000.00 |
| • Pig   | \$400.00   |
| • Lamb  | \$200.00   |

*A monthly statement will be mailed to you to account for costs and purchases.*

#### Charge Account Terms:

Payment is due as follows, whether the animal sells or not:

- Lamb account balances are due in full by **August 31st.**
- Steer & Swine account balances are due in full by **October 31th.**
- Finance charges will occur at 1.5% per month or 18% per year for past due accounts.
- Purchases will be limited to feed and products related to **4H/FFA market animals only.**
- Unpaid balances will be considered past due and subject to standard collection procedures.
